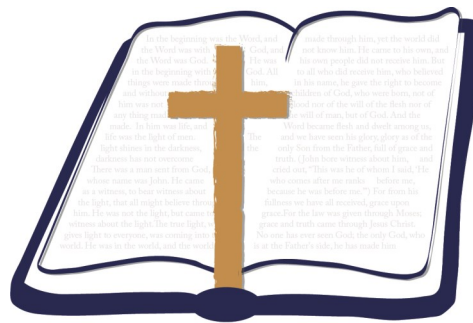

Proposed Revision to Church Covenant of Westmont Baptist Church

Having been saved by grace through faith in Jesus Christ, and recognizing these duties laid upon us by God's Word, we do now, relying on His gracious aid, joyfully and solemnly renew our covenant with each other as members of this church. (Eph 2:8; John 14:15; Acts 2:42; 2 Thessalonians 1:11-12; Joshua 24:1-28; Nehemiah 9:38ff; Jeremiah 34:8; 1 Cor 1:2; 1 Cor 12:27)

We will not forsake the assembling of ourselves together for the glory of God and the upbuilding of the church, and will faithfully sustain this church's worship, ordinances, discipline and doctrines. (Heb 10:24-25; Ephesians 3:10; 1 Cor 14:26; Psalm 149:1; Psalm 34:3; Revelation 7:9-10; Col 3:16; Matt 28:19; 1 Cor 11:17-34; Matt 18:15-20; 1 Tim 3:15; Gal 1:6-9)

We will strive together for the advancement of the gospel of the kingdom by faithfully supporting the ministry of this church. (Matt 28:19-20; Phil 1:5,12, 27; 1 Thes 1:8; Ephesians 4.11-13; Roman 12:4-8; 1 Tim 5:17-18)

We will aspire to exercise Christian love toward one another and be eager to maintain unity for the glory of Christ. (John 13:34-35, John 17:22; Eph 2:14-16, Eph 4:1-6; Col 3:14; 1 John 4:7-21)

We will teach and admonish one another with God's Word, and will be unashamed in our proclamation of the gospel to the world around us. (Matt 28:20; 1 Thes 2:12; Col 1:28; Col 3:16; Titus 1:9; 1 Tim 4:13; 2 Tim 2:2; Titus 2:1-4; Eph 6:4; Deut 6:7; 1 Thess 5:14; 2 Thes 3:6-15; Romans 1:16; 1 Cor 9:16; Acts 1:8)

We will conduct our lives worthy of the gospel of Christ by walking in obedience to his commands in Scripture. (Eph 4:1; Gal 2:14; Phil 1:27; John 14:15; Rom 1:5)

We will, if we move from this place, as soon as possible, unite with some other church where we can carry out the spirit of this covenant and the principles of God's Word. (Heb 10:24-25; Acts 18:27-28; Rom 16:1-2)

May the grace of the Lord Jesus Christ, and the Love of God, and the fellowship of the Holy Spirit be with us all. (2 Cor 13:14)
